**Sex Offender Conditions**

*The following conditions are in addition to the general conditions of Probation and Parole:*

1. You are directed to obtain a sex offender evaluation by an agency designated by the York County Probation Department and follow through with all recommendations as per this evaluation, including the successful completion of the sex offender program. You will assume all responsibility for the costs of any required program.
2. If your offense qualifies under Megan's Law, you are required to follow the Sexual Offender Registration procedures as currently applicable under state law.
3. If you are subject to the DNA requirements (Act 14 of 1995 or Act 57 of 2002), you will be required to follow through with testing procedures as arranged by your Probation Officer.
4. You are required to obtain approval before leaving the jurisdiction of the Court and you must secure travel permission before leaving the state. If directed by your Probation Officer, you will keep a log of your activities
5. You will have no contact whatsoever with the victim(s) in the case unless otherwise specified by a Court Order. You will be responsible for restitution for the victim's counseling if appropriate.
6. If your current offense involved a minor child, there will be no unsupervised or **unauthorized** contact with minors. **Any** contact with minors must be **pre-approved** by the Probation Department. Prohibited contact includes, but is not limited to: frequenting any area or activity which is regularly attended by minor children, e.g. schools, playgrounds, swimming pools, carnivals, arcades, ect.; residing with minor children; occupying or traveling in a motor vehicle with a minor; cohabiting or sharing a residence with any individual who has minor children.
7. You will not purchase, possess, or transport any pornographic material. This includes, but is not limited to, photographs, magazines, movies, videotapes, and sexually explicit stories downloaded from the Internet. If you have access in your home or place of employment to a computer, Internet access will be prohibited.
8. You will not have any alcohol, illegal drugs, or drug paraphernalia anywhere in your residence,

vehicle, or on your property. You are responsible for the removal of any existing alcohol, illegal drugs, or drug paraphernalia from your residence, vehicle, or property. You are also responsible to insure that no one in your household brings any alcohol, illegal drugs, or drug paraphernalia into your residence during your term of probation/parole. If found, alcohol, illegal drugs, or drug paraphernalia will be ***presumed to be yours.***

9. You will be required to undergo counseling (i.e. Mental Health, Drug and Alcohol) if deemed appropriate by your Probation Officer.
