



PCPC TRAINING

This course will include a historical overview of the updated PCPC; a review of the assessment process; and the nine levels of care within the criteria.

There will be instructions on how to use the admission, continued stay and discharge criteria and a review of special needs populations.

All participants will participate in case studies to gain experience and practice in using this assessment tool.
