Protection from Abuse (PFA)

All petitions under the Protection from Abuse Act shall be presented through the PFA Office. Hearings will be held at 1:00 p.m. on Mondays and Thursdays. When a holiday falls on a Monday, hearings will be scheduled on the following Tuesday. Ex parte hearings for emergency PFAs will be heard Monday through Friday at 1:00 p.m., and at other times thereafter based on the court's availability.

Emergency Child Custody

Emergency child custody petitions shall be presented to the Office of Court Administration for assignment and scheduling.

Complex Support

Requests for specially scheduled de novo hearings shall be presented to the Office of Court Administration for assignment and scheduling.

Motions Court

Motions Court sessions regarding divorce, custody and support proceedings will be held Monday and Wednesday of each week commencing at 9:00 a.m. All motions shall be presented to the Office of Court Administration and opposing parties at least five calendar days prior to the desired session of Motions Court.
