The gay, lesbian, bisexual, and transgender community of individuals is identified as a special needs population. This workshop provides a first level of competency for substance abuse treatment with this population. This workshop employs two modalities: didactic and experiential. The training will address a continuum of gender and sexual orientation, the connections between the lesbian, gay, bisexual and transgender person and their unique experience with addiction and recovery issues.
