



# Motivational Interviewing

This course is designed to familiarize participants with the concepts behind the development of Motivational Interviewing (MI) and the applications of this approach to the treatment of the substance abuse population. Participants will learn how to modify the client-centered aspect of MI until the client has achieved a solid strength and length of sobriety. The course will review proven motivational strategies and give participants the opportunity to practice these methods.

**Trainer:** Nancy Milliron, MS CAC CCMS LPC.

A drug and alcohol professional for over 28 years, Ms. Milliron has had the opportunity to work in all phases of the drug and alcohol services including prevention, treatment, both residential and outpatient, and case management. Currently Nancy is the Facility Director at Another Way, a halfway house for women in Uniontown, PA. She is a founding member of PACNET, Pennsylvania Case Management Network, the professional organization for drug and alcohol case managers. She is a member of several regional health Choices committees and she has been a DDAP trainer for a number of years
