

YORK COUNTY APPROVED CONSTABLES

(June 15th, 2016)

Approved constables may be assigned duties by the York County judicial system and will have access to the York County Missile System for warrants.

All non-York County elected constables shall be required to file with the York County Clerk of Courts on an annual basis a certified copy of their bond and certificate of insurance, and every time their oath of office is renewed, a certified copy of their oath of office that is filed with the Clerk of Courts of the County in which they were elected.

AFFIDAVIT OF COMPLIANCE: In order to remain on the York County Approved Constables list, every approved Constable shall file with each Magisterial District Judge who has recommended that Constable an Affidavit of Compliance that the Constable is in compliance with the Constable Policies, Procedures and Standards of Conduct of the Pennsylvania Unified Judicial System within seven days of being placed on the York County Constable list and annually thereafter, no later than January 7 of each year.

Any elected Constable (York County or non-York County) who desires to be considered being added to the approved Constable list must apply to the York County District Court Administrator and be recommended by a York County Magisterial District Judge.
