 - B. Subsidized Adoption Assistance Agreement First Amendment between the County of York, on behalf of the York County Office of Children, Youth & Families, and **CK and MN of Mechanicsburg, PA**, the adoptive parents, to reflect a change in the name of the child **JDHN fka JDZ IV**, with all other terms and conditions of the original agreement remaining in full force and effect.
 - C. - Motion to approve a contract agreement between the County of York, on behalf of the Human Services Department, and **Northeastern School District, Manchester, Pennsylvania**, to provide funding to Lakeside Education Network for the provision of the three-part Neurologic Trauma Informed Care training program.
- Motion to approve a contract agreement between the County of York, on behalf of the Human Resources Department, and **Steve Gilliland, Inc., Mocksville, North Carolina**, to present "Making a Difference" on April 16th, 2019 for a York County Employee event, for a total cost of \$12,000.00, plus hotel accommodation.

Since there was no agreement between the state and the county which included the continuation of the old assessment process an amendment was required for monies to be dispersed.
