

**ORDINANCE 89-3**  
**SIGNIFYING INTENTION TO ORGANIZE**  
**AIR TRANSPORTATION AUTHORITY OF YORK COUNTY**  
**UNDER THE MUNICIPALITY AUTHORITIES**  
**ACT OF 1945**

**WHEREAS**, the Board of Commissioners of the County of York ("The County"), a county of the third class of the Commonwealth of Pennsylvania, has held a public hearing, the notice of which was given as provided in the Municipality Authorities Act of 1945, Act of May 2, 1945, P.L. 382, as amended, 53 P.S. Section 301 et seq. ("The Act"), on adopting an Ordinance signifying their intention to organize the Air Transportation Authority of York County as an Authority under the Act; and

**WHEREAS**, the Board of Commissioners of the County, after such public hearing, does intend to organize the Air Transportation Authority of York County as an Authority under the Act,

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED** that the County as incorporating municipality shall cause to be filed with the Secretary of the Commonwealth of Pennsylvania, Articles of Incorporation for the proposed Authority substantially as follows:

- a) The name of the Authority: Air Transportation Authority of York County.
- b) The Authority is formed under the Municipality Authorities Act of 1945.
- c) The purpose of the Authority is to study current air transportation needs and to provide recommendations for, and to carry out the purpose of acquiring, holding, constructing, financing, improving, maintaining and operating, owning, leasing, either in the capacity of lessor or lessee, all facilities necessary or incidental to the operation of one or more airports in York County.
- d) Any other Authority, or Authorities, organized and in existence for the incorporating municipality: York Area Transportation Authority and York County Solid Waste Authority.
- e) The name of the incorporating municipality is: County of York, Pennsylvania, One West Marketway, Fourth Floor, York, Pennsylvania 17401.
- f) The names, addresses and terms of office of the first members of the Board of the Authority: Messrs. Murray Friedman, 1000 Detwiler Drive, York, PA 17404 (3-year term, 1989-1992); William Simpson, 2532 Hepplewhite Drive, York, PA 17404 (3-year term, 1989-1992); Charles Bacas, 663 Madison Avenue, York, PA 17404 (2-year term, 1989-1991); David Carver, Industrial Development Corporation, 1 Market Way East, York, PA 17404 (2-year term, 1989-1991); David Keperling, R.D. #3, Spring Grove, PA 17362 (1-year term, 1989-1990).

- g) The County as incorporating municipality has retained the right, which exists under the Act, to approve any plan of the Authority, in the case of Authorities created for the purpose of making business or administrative improvements, if any.
