ORDINANCE 1999-04

ADDITIONS/AMENDMENTS TO THE YORK COUNTY CODE

AN ORDINANCE ADDING NEW SECTIONS OR AMENDING SECTIONS TO THE YORK COUNTY CODE TO AMEND THE BY-LAWS OF THE YORK COUNTY ADVISORY BOARD OF PARKS AND RECREATION, TO INCORPORATE THE Y2K ACTION PLAN, TO INCORPORATE THE HOMESTEAD OR FARMSTEAD EXEMPTION APPLICATION FILING POLICY, TO INCORPORATE THE DESIGNATION OF THE YORK COUNTY INDUSTRIAL DEVELOPMENT CORPORATION AS THE COUNTY'S INDUSTRIAL DEVELOPMENT REPRESENTATIVE, TO INCORPORATE THE SETTLEMENT DATE POLICY FOR DELINQUENT TAXES, TO INCORPORATE THE YORK COUNTY GOVERNMENT SAFETY POLICY, TO INCORPORATE THE YORK COUNTY COMPREHENSIVE RECORDS MANAGEMENT PLAN, AND TO AMEND THE EFFECTIVE DATE OF THE UNIFORM PARCEL IDENTIFIER ORDINANCE.

IT IS HEREBY ORDAINED AND ENACTED, by the Board of Commissioners of the County of York, Commonwealth of Pennsylvania, the following Ordinance adding new sections, or amending existing sections of the York County Code, or amending an existing ordinance.

1. An amendment changing Section 423.9 of the Code to expand York County Advisory Board of Parks and Recreation membership criteria, as attached hereto and incorporated herein.

2. An addition to the Code incorporating the Y2K Action Plan, attached hereto as Resolution 1999-01 and incorporated herein.

3. An addition to the Code incorporating the Homestead and Farmstead Exemption Application Filing Policy, attached hereto as Resolution 1999-02 and incorporated herein.

4. An addition to the Code incorporating the designation of the York County Industrial Development Corporation as the County industrial development representative, attached hereto as Resolution 1999-08 and incorporated herein.

5. An addition to the Code incorporating the designation of January 15, 2001 as the settlement date for delinquent taxes, attached hereto as Resolution 1999-10 and incorporated herein.

6. An addition to the Code incorporating the York County Government Safety Policy, attached as Resolution 1999-15 and incorporated herein.


7. An addition to the Code incorporating the Comprehensive Management Plan, attached as Resolution 1999-16 and incorporated herein.

8. An amendment to Ordinance 1999-03 changing the effective date to January 1, 2001.



AMENDMENT TO THE CODE OF YORK COUNTY, PENNSYLVANIA  
DELETING THE EXISTING AND ADDING NEW SECTION 423-9 OF PART III,  
CHAPTER 423 ADVISORY BOARD OF PARKS AND RECREATION

Section 423-9 Part III, Chapter 423 of the Code of York County establishing the term of membership is repealed; and a new Section 423.9 is added to read as follows:

Section 423-9. Term.

Each member of the Advisory Board shall serve at the pleasure of the Board of County Commissioners, but for a term not to exceed three (3) years. Any member may be re-appointed by the Board of Commissioners. No member shall serve more than two (2) consecutive terms. At the conclusion of the second term and one (1) year or more absence from the Board, an individual may be re-appointed to the Board by the Board of Commissioners.
