ORDINANCE 2002-01

ADDITIONS/AMENDMENTS TO THE YORK COUNTY CODE

AN ORDINANCE ADDING NEW SECTIONS OR AMENDING SECTIONS OF THE YORK COUNTY CODE TO INCLUDE A CHANGE TO TAX COLLECTOR COMPENSATION, CHANGE TO THE MEMBERSHIP OF THE YORK COUNTY HOSPITAL AUTHORITY, CHANGE TO THE DESIGNATION OF THE YORK COUNTY ECONOMIC DEVELOPMENT CORPORATION DESIGNATION AS THE INDUSTRIAL DEVELOPMENT ORGANIZATION, CHANGE TO THE COUNTY ORGANIZATION CHART, CHANGE TO COURTHOUSE SECURITY PROCEDURES, ADDING A SERVICE PROVIDER CONTRACT APPEAL PROCEDURE TO THE YORK/ADAMS MENTAL HEALTH-MENTAL RETARDATION AND DRUG AND ALCOHOL PROGRAMS, ADDING A PET POLICY, AND ADDING A CLEAN AND GREEN APPLICATION FEE.

IT IS HEREBY ORDAINED AND ENACTED, by the Board of Commissioners of the County of York, Commonwealth of Pennsylvania, the following Ordinance amending existing and adding new sections to the York County Code:


1. An amendment changing Section 325-6 of the Code to establish tax collector compensation for the four (4) year term beginning January 7, 2002, attached hereto as Resolution 2001-003 and incorporated herein.
2. An amendment changing Section 11-10 of the Code to add the existing members of the General Authority of Southcentral Pennsylvania as additional board members of the York County Hospital Authority, attached hereto as Resolution 2001-05 and incorporated herein.
3. An amendment changing Section 221-1 of the Code to extend the designation of the York County Economic Development Corporation as the Industrial Development Organization of the County, attached hereto as Resolution 2001-08 and incorporated herein.
4. An amendment changing Section 73-1 of the Code revising the County Organization Chart, as attached hereto and incorporated herein.
5. An amendment changing Chapter 301 of the Code revising the security procedures at the York County Courthouse, as attached hereto and incorporated herein.
6. An addition to Chapter 411 of the Code incorporating York/Adams Mental Health-Mental Retardation and Drug and Alcohol Programs service provider contract negotiation appeal procedures, as attached hereto and incorporated herein.
7. An addition to Chapter 263 incorporating a pet policy, as attached hereto and incorporated herein.


