RESOLUTION NO. 2004- 10

**A RESOLUTION OF CHANCEFORD TOWNSHIP, YORK COUNTY,
PENNSYLVANIA, ADOPTING HEATHER WAY LOCATED WITHIN
CHANCEFORD TOWNSHIP, YORK COUNTY, PENNSYLVANIA, AS AN
OFFICIAL STREET.**

WHEREAS, a Subdivision Plan of "Brownton View Estates" has been duly recorded in the Office of the Recorder of Deeds in and for York County, Pennsylvania, in Plan Book SS, Page 389; and

WHEREAS, the following street as shown on said Plan was offered for dedication to the public and has been improved in accordance with standards established by Chanceford Township.

NOW THEREFORE, be it resolved by the Board of Supervisors of Chanceford Township, York County, Pennsylvania, that the following street as shown on the aforesaid Subdivision Plan of "Brownton View Estates" is hereby accepted for dedication as a public street of said Township:

HEATHER WAY

BEGINNING at a point in the centerline intersection of Brownton Road (SR 2056) and the within described Heather Way; thence along the centerline of said Heather Way, South twenty-eight (28) degrees, forty-three (43) minutes, fifty-nine (59) seconds East, nineteen and sixty-three one-hundredths (19.63) feet to a point; thence by the same, along the arc of a curve to the right having a radius of two hundred and zero one-hundredths (200.00) feet, a distance of three hundred sixteen and eighty-six one

hundredths (316.86) feet the chord of which is South sixteen (16) degrees, thirty-nine (39) minutes, thirteen (13) seconds West, two hundred eighty-four and seventy-five one-hundredths (284.75) feet to a point; thence by the same South sixty-two (62) degrees, two (02) minutes, twenty-five (25) seconds West, six hundred sixty-three and fifty-one one-hundredths (663.51) feet to a point, said point being the locus of a cul-de-sac having a radius of sixty (60) feet, said point also being the terminus of the within described. Containing 1,000 linear feet (0.19 mile). This road throughout being not less than thirty-three (33) feet in width.

Be it further resolved that the above described street be designated as a Township Street on the official street map of the Township.
